

BARNSTABLE COUNTY

In the Year Nineteen Hundred and Ninety

Ordinance 90 - 11

To authorize the County to make necessary repairs, replacements and improvements to, and to purchase and install equipment for use in, buildings and facilities of the County, and to borrow money to pay therefor.

Barnstable County hereby ordains:

Section 1. The Board of County Commissioners is hereby authorized to make necessary repairs, replacements and improvements to, and to purchase and install equipment for use in, buildings and facilities of the County, and to employ professional services for the design of such repairs, replacements, improvements and for the specification of such purchases and installation of equipment, as follows:

- (a) interior repairs, including repairs to the ceiling of the main courtroom, in the Barnstable Superior courthouse in the town of Barnstable;
- (b) replace the roof water chillers for the air conditioning at the First District courthouse in the town of Barnstable and at the Second District courthouse in the town of Orleans;
- (c) equipment to augment telephone-service capacity for buildings in the County complex in the town of Barnstable;
- (d) equipment for the health department laboratory in the said Barnstable Superior courthouse;
- (e) renovation and improvement of the electrical wiring of the County hospital at Pocasset in the town of Bourne;
- (f) renovation and improvement of the fire-sprinkler system of the said County hospital;
- (g) renovation and improvement of the emergency generator of the said County hospital;
- (h) Flex Alarm system for the said County hospital;
- (i) computer, data-processing and related equipment and computer software for the Department of Finance; and
- (j) computer, data-processing and related equipment; computer software; copying equipment; audio and/or visual recording, amplification, transmission and display equipment; and furniture and furnishings for the Assembly of Delegates; all as determined by the Speaker thereof.

Section 2. The Board of County Commissioners is hereby further authorized to make necessary repairs, replacements and improvements to buildings and facilities of the County, and to employ professional services for the design of such repairs, replacements, improvements, as follows:

- (a) roofs, exterior walls and chimney of the said Barnstable Superior courthouse; and
- (b) roofs of the Registry of Deeds and Probate building.

Section 3. All work done on the said Barnstable Superior courthouse pursuant to this ordinance shall so far as practicable conform to pertinent standards for historic preservation projects promulgated by the U. S. Secretary of the Interior.


Section 4. For the purposes set forth in section one, the County Treasurer, with the approval of the County Commissioners, may borrow from time to time, on the credit of the County, such sums as may be necessary, not exceeding, in the aggregate, four hundred and twenty-five thousand dollars, and may issue bonds or notes of the County therefor, which shall bear on their face the words, Barnstable County Facilities and Equipment Loan, County Ordinance of 1990. Each authorized issue shall constitute a separate loan, and such loans shall be payable in not more than five years from their dates.

Section 5. For the purposes set forth in section two, the County Treasurer, with the approval of the County Commissioners, may borrow from time to time, on the credit of the County, such sums as may be necessary, not exceeding, in the aggregate, four hundred and twenty-five thousand dollars, and may issue bonds or notes of the County therefor, which shall bear on their face the words, Barnstable County Capital Improvements Loan, County Ordinance of 1990. Each authorized issue shall constitute a separate loan, and such loans shall be payable in not more than ten years from their dates.

Section 6. All bonds or notes issued pursuant to this ordinance shall be signed by the County Treasurer and countersigned by a majority of the County Commissioners. The County may sell securities at public or private sale upon such terms and conditions as the County Commissioners may deem proper but not for less than their par value. Indebtedness incurred under this ordinance shall, except as herein provided, be subject to chapter thirty-five of the Massachusetts General Laws.
