

BARNSTABLE COUNTY ASSEMBLY OF DELEGATES

In the Year Nineteen Hundred and Ninety-Five

Ordinance 95-1

To authorize the County to make necessary repairs, replacements and improvements to, and to purchase and install equipment for use in, buildings and facilities of the County, and to borrow money to pay therefor.

Barnstable County hereby ordains:

SECTION 1: The Board of County Commissioners is hereby authorized to make necessary repairs, replacements and improvements to, and to purchase and install equipment for use in buildings and facilities of the County, and in conducting the business of the County, and to employ professional services for the design and engineering of such repairs, replacements and improvements, and for the specification of such purchases and installation of equipment as follows:

- a) purchase of equipment for the Cooperative Extension Service at the said Barnstable County Superior Courthouse;

SECTION 2. The Board of County Commissioners is hereby further authorized to make necessary repairs, replacements and improvements to buildings and facilities of the County, and to employ professional services for the design and engineering of such repairs, replacements and improvements, and installation of equipment as follows:

- a) interior and exterior repairs, including boiler repairs, window replacement, asbestos removal and sewer and drain improvements in the Barnstable County Superior Courthouse building in the town of Barnstable;
- b) renovations and improvements necessary to install computer, data-processing and related equipment and software for the Registry of Deeds building in the town of Barnstable;
- c) HVAC and building systems improvements including chillers, handicapped access and interior renovations at the First District Courthouse in Barnstable and the Second District Courthouse in Orleans;
- d) facility improvements including handicapped access, improvements necessary to comply with the ADA and sewer and drain improvements at the County Complex in the town of Barnstable; and
- e) development of plans and specifications for a new burn building at the Fire Training facility.


SECTION 3. All work done on the said Barnstable County Superior Courthouse pursuant to this ordinance shall so far as practicable conform to pertinent standards for historic preservation projects promulgated by the U.S. Secretary of the Interior.

SECTION 4. For the purposes set forth in Section 1, the County Treasurer, with the approval of the County Commissioners, may borrow from time to time, on the credit of the County, such sums as may be necessary, not exceeding, in the aggregate ten thousand dollars, and may issue bonds or notes of the County therefor, which shall bear on their face the words, Barnstable County Facilities and Equipment Loan, County Ordinance of 1995. Each authorized issue shall constitute a separate loan, and such loans shall be payable in not more than five years from their dates.

SECTION 5. For the purposes set forth in Section 2, the County Treasurer, with the approval of the County Commissioners may borrow from time to time, on the credit of the County, such sums as may be necessary, not exceeding, the the aggregate one hundred and ninety-four thousand, five hundred and forty dollars, and may issue bonds or notes of the County therefor, which shall bear on their face the words, Barnstable County Facilities and Equipment Loan, County Ordinance 1995. Each authorized issue shall constitute a separate loan, and such loans shall be payable in not more than ten years from their dates.

SECTION 6. All bonds or notes issued pursuant to this ordinance shall be signed by the County Treasurer and countersigned by a majority of the County Commissioners. \ The County may sell securities at public or private sale upon such terms and conditions as the County Commissioners may deem proper but not less than par value. Indebtedness incurred under this ordinance shall, except as herein provided, be subject to chapter thirty-five of the Massachusetts General Laws.
