

BARNSTABLE COUNTY ASSEMBLY OF DELEGATES

In the Year Nineteen Hundred and Ninety-Five

Ordinance 95-3

In accordance with Article 2 -- Legislative Branch: Section 2-8, (d)(v), of the Barnstable County Home Rule Charter, to establish the rate for landfill monitor well analysis.

Barnstable County hereby ordains:

SECTION 1: The Barnstable County Department of Health and the Environment is hereby authorized to charge laboratory fees for Landfill Monitor Well Analysis, effective July 1, 1995, according to the following schedule:

(The Director of the Barnstable County Department of Health and the Environment may deviate from the prices quoted for governmental units outside Barnstable County depending on Sample Volume, Frequency and Duration of Analysis. This price latitude will never be less than Barnstable County Water Supplier rates or more than average market rates for private laboratories.)

SECTION 2. For analysis that the County Lab is not equipped to perform, the County will subcontract with private laboratories to perform this service. The Department of Health and the Environment will bill the towns or other entities utilizing the landfill monitoring well analysis services at the rates established in this ordinance for testing performed by the County and at the cost charged the County by the private labs for the services which are subcontracted. Funds collected/charged from the towns or other entities for the subcontracted services will be deposited in a special account which will be used to pay the subcontracting labs for performance of the testing services.
