Based on a revised estimate of income of Barnstable County for the current fiscal year, made as of September 30, 2020, the sum set forth in section one, for the purpose set forth therein and subject to the conditions set forth in section one through five of Barnstable County Ordinance 20-16, are hereby appropriated from Unreserved Fund Balance for Barnstable County for the fiscal year ending June thirtieth, two thousand and twenty-one. Said funds are to be transferred to the General Stabilization Fund for the General Stabilization fund for the purpose of setting aside funds that are to be invested to secure reserves for a variety of projects and other needs. Said funds shall be derived from Unreserved Fund Balance for FY2021

Said funds are to be transferred to the General Stabilization Fund for the Capital Stabilization for the purpose of setting aside funds that are to be invested to secure reserves for future capital purchases. Said funds shall be derived from Unreserved Fund Balance for FY2021

Said funds shall be derived from Unreserved Fund Balance for FY2021
