Section 3.

All bonds or notes issued pursuant to this proposed ordnance shall be signed by the County Treasurer and countersigned by a majority of the County Commissioners. The County may sell securities at public or private sales upon such terms and conditions as the County Commissioners may deem proper but not at a price of less than par value. Indebtedness incurred under this proposed ordinance shall, except as herein provided, be subject to Chapter 35 of the Massachusetts General Laws.
