The Executive Director of Falmouth Housing Authority, informed the CA via email on 6.7.21 of their decision to not renew their CRHI grant in FY2021 because of the administrative burden and funding difficulties. The Policy Board was informed of FHA's voluntary decision at their 6.28.21 meeting. FHA has adjusted their tenant selection process to include those formerly homeless and have therefore considered CRHI tenants eligible for their other subsidized programs to avoid anyone from becoming homeless.







Failure to either submit one form per project or one form with a listing of project information for each field (i.e., name of applicant, name of project, location of project) will result in a technical deficiency notification that must be corrected within the number of days designated by HUD, and further failure to provide missing or incomplete information will result in project application removal from the review process and rejection in the competitive process.
