#### **Barnstable County HOME Consortium Annual Action Plan for Program Year 2022**

The Barnstable County HOME Consortium has prepared its Annual Action Plan for Program Year 2022 (PY22). This plan outlines funding priorities and serves as the strategic and planning documents for Barnstable County's HOME Program which is funded by the U. S. Department of Housing and Urban Development (HUD).

The Barnstable County HOME Consortium will conduct a public meeting on **Thursday, April 21, 2022 at 3:00 p.m. via a virtual meeting** pursuant to Chapter 20 of the Acts of 2021, An Act Relative to Extending Certain Covid-19 Measures Adopted During the State of Emergency, signed into law on June 16, 2021 and extended pursuant to Chapter 22 of the Acts of 2022 signed into law on February 15, 2022. The purpose of this public meeting is to obtain oral and/or written comment from citizens, public agencies, community organizations, and interested parties relative to the Annual Action Plan for Program Year 2022 (July 1, 2022 to June 30, 2023). The HUD allocation for PY22 is estimated to be \$450,000 plus approximately \$170,000 in repurposed program income.
