V. General Business

1. AmeriCorps Cape Cod Year 20 Celebration

Ms. Hutchinson mentioned that having one day a week placement is challenging because there isn't enough time for the member to get things completed. Kayla Baier responded with it is also a challenge for members to retain volunteers with only day a week. Ms. Baier concluded that an end of the year assessment of the placement will be factored into the IP selection as well as increasing questions during IP Site Visits.
