# Presentation: Cynthia Ouellette – Coordinator, Fire Data and Public Education Unit, MA Department of Fire Services

Cynthia discussed the major causes of fires and how to prevent them. Three methods to preventing and reducing the number of fires include: changing the heat source; changing the fuel source and changing the behavior. Changing the behavior is the hardest method to address. However, through programs and events fire departments have been able to improve education and awareness; addressing those behavioral changes. Successful programs include: SAFE, student awareness of fire education and Senior SAFE. Both programs provide grants to local fire departments to teach either students or seniors about fire safety. And the Keep Warm, Keep Safe campaign to create awareness of home heating fires during the winter months. Cynthia also discussed the leading causes of fires: cooking and smoking. She provided tips on keeping safe from fires – working smoke detectors, sleeping with doors closed, keeping flashlights by the bed, having an escape plan and knowing that smoke inhalation is the reason most people die in fires.

MA Fire incident reports do not track hoarding because there is no federal code for it; inspectors are relied upon to report cluttering. The audience suggested supporting an effort to make a change in the federal code to begin recording hoarding in incident reports. It is estimated that 3 out of 39 fatal fires in Massachusetts this year were due to cluttering and hoarding. Chris DiNapoli from Hingham Fire mentioned that the town of Hingham includes descriptions of houses of known hoarding cases on the hazardous buildings list. This proves to be helpful in the chance of a fire. And the town of Framingham posts Clutter Image Rating Scales in fire trucks. Someone in the audience suggested creating a fire safety sheet that could be given to clients with hoarding disorder to reduce risk of fire and increase safety.
