The CoC Collaborative Applicant reviewed the spend down on project applications and sent a request to Housing Assistance Corporation (HAC) on July 21, 2023, notifying them of the need to reallocate funds from their Housing First project because they have not been spending down the funds. HAC responded on July 24, 2023, and agreed to reallocate funds. Because the residents are long term and pay toward the rent, the Actual Rental calculations can be adjusted, thus safely reducing the renewal amount and ensuring that the 8 residents can continue to be housed.

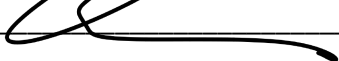
