

**In the Year Two Thousand Twenty-Two**  
**Ordinance 22-17**

Whereas the Assembly and the Board wish to work cooperatively and in an efficient manner to distribute the ARPA funds to eligible recipients for worthwhile projects; and

Whereas Barnstable County has received, \$41,370,811 in grant funds from the United States Department of the Treasury under the American Rescue Plan Act (ARPA), signed on March 3, 2021; and

Whereas in March 2022 the Barnstable County Board of Commission appointed an ARPA Advisory Committee to advise the Barnstable County Board of Commissioners and Assembly of Delegates on regional funding priorities, recommend criteria to identify projects of regional impact for funding, and identify eligible entities to apply for funding; and

Whereas the ARPA Advisory Committee voted on initial recommendations on 6/30/22, wherein a project by the Cape Cod Commission entitled Regional Housing Strategy was recommended for funding; and

Whereas the ARPA Advisory Committee wishes to submit this recommendation to the Board of Commissioners;

**The Cape Cod regional government, known as Barnstable county, hereby ordains;**

**Section 1.**


**Allocation of County ARPA Funds to the Cape Cod Commission Regional Housing Strategy**

1.a. \$932,576 shall be allocated to fund the Regional Housing Strategy project from County ARPA funds.

1.b. Said funds are to be expended only for purposes and in the ways set forth in the U.S. Department of the Treasury Coronavirus State & Local Fiscal Recovery Funds: Interim and Final Rule (published 1/6/22), or any subsequent directives issued.


