## Our Work, for You:

## **Advisory Council**

The Health & Human Services Advisory Council, established by Ordinance, consists of regional human service professionals who advise the County regarding the human services needs of its residents.

## **Aging Well & Healthy Living**

Healthy Aging Cape Cod is a collaborative effort among organizations serving older adults in Barnstable County to align existing services to better enable residents to age in place successfully.

#### **Behavioral Health**

The Children's Behavioral Health Work Group (CBHWG) charge is to increase access to, and maximize the efficacy of, the region's behavioral health system of care for the age 0-21 population through collaboration, advocacy, education and training. CBHWG identifies challenges and works to develop comprehensive and sustainable solutions.

# **Housing and Homelessness** *CoC*

The Department is the collaborative applicant for the Cape Cod & Islands Continuum of Care (CoC) and the convening agency for the Regional Network on Homelessness. As Collaborative Applicant, the Department is responsible for developing the annual application for CoC funding through the US Department of Housing & Urban Development

#### **HMIS**

The Department is the Homeless Management Information System lead for the Cape Cod & Islands CoC. Functions include managing the Coordinated Entry System (CES) to access CoC funded programs, providing user training and technical assistance, reporting, grantee monitoring and conducting the annual homeless count.

#### HOME

The Department is the HOME Investment Partnership Program, a federal block grant to state and local governments designed exclusively to create affordable housing for lowincome households. The HOME program funds a range of activities for the acquisition, creation and retention of affordable housing. The Barnstable County HOME Consortium, comprised of the 15 towns in Barnstable County, is a Participating Jurisdiction to receive and disburse HOME funds. Fund disbursement is by vote of the HOME Consortium Advisory Council.

#### YYA

The Department, in collaboration with the Massachusetts Executive Office of Health and Human Services, initiative to address Youth and Young Adult Homelessness and to implement the recommendations of the Special Commission on Unaccompanied Homeless Youth throughout Barnstable County and the Islands.

#### SHINE

The Cape and Islands Regional SHINE (Serving the Health Insurance Needs of Everyone) Program supports Massachusetts residents throughout the region by providing free, and unbiased one-on-one health insurance counseling, enrollment assistance and public benefit screening to Medicare beneficiaries, their family members, caregivers, and representatives.

#### **Substance Use Prevention**

In collaboration with the Massachusetts
Department of Public Health, the Department
manages substance use grants to educate
and enhance capacity on Cape Cod with our
many community-based service providers.
The Department convenes the Regional
Substance Addiction Council comprised of
town and community leaders whose purpose
is to establish a communication infrastructure
across towns, providers, organizations, and
individuals on Cape Cod; to identify needs
and address gaps and disparities in the
service system; to maximize interagency
collaboration; and to maximize funding and
resource opportunities.
